



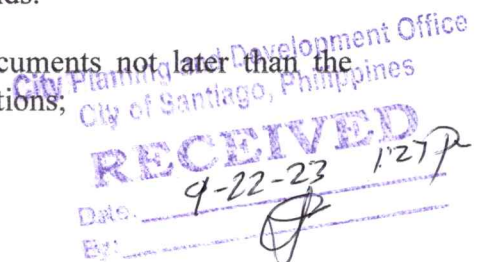
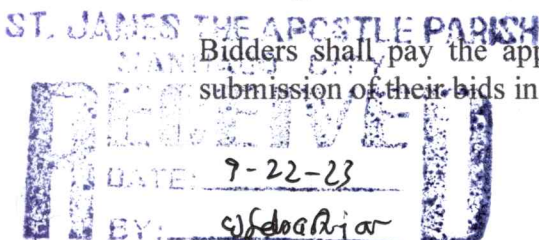
INVITATION TO BID FOR

SUPPLY, INSTALLATION, RETROFITTING, EQUIPMENT/WATER TESTING, AND COMMISSIONING OF ONE (1) ASSEMBLY MODULAR WATER TREATMENT FOR THE WATER QUALITY IMPROVEMENT OF PALOGAN PUMP STATION AT DIVISORIA, SANTIAGO CITY

1. The **SANTIAGO WATER DISTRICT (SANWAD)**, through the *Corporate Budget for the Year 2023* intends to apply the sum of **Two Million Five Hundred Fifty Thousand Pesos (Php 2,550,000.00)** being the ABC to payments under the contract for **Supply, Installation, Retrofitting, Equipment/Water Testing and Commissioning of One (1) Assembly Modular Water Treatment for the Water Quality Improvement of Palogan Pump Station at Divisoria, Santiago City with Purchase Request No.56694** . Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **SANWAD** now invites bids for the above Procurement Project. Delivery of the Goods is required *within 30-45 calendar days upon receipt of the Notice to Proceed*. Bidders should have completed, within *within three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from **SANWAD BAC Secretariat** and inspect the Bidding Documents at the address given below during **office hours 8am-5pm**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **September 20, 2023** from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person, by facsimile, or through electronic means*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity (<http://www.sanwad.gov.ph>), provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

Bidders shall pay the applicable fee for the Bidding Documents **not later than the submission of their bids** in any of the following payment options;

Upon payment, bidders are advised to coordinate with the BAC Secretariat and kindly email or fax the deposit slip or any proof of online fund transfer for the issuance of the Official Receipt.

6. The **SANWAD** will hold a Pre-Bid Conference¹ on **September 28, 2023 at 10:00 AM** at **SANWAD Office Conference Room 03 Carreon St. Centro East, Santiago City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **October 18, 2023 at 9:00 AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **October 18, 2023 at 10:00 AM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **SANWAD** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
