## Invitation to Bid for

### SUPPLY OF LABOR AND MATERIALS FOR THE DRILLING OF ONE (1) PRODUCTION WELL AT BAÑEZ ST. DUBINAN WEST, SANTIAGO CITY

The *Santiago Water District (SANWAD)*, through its Corporate Budget for the Year 2024 intends to apply the sum of *Four Million Five Hundred Thousand Pesos (P 4,500,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Supply of Labor and Materials for the Drilling of One (1) Production Well at Bañez St. Dubinan West, Santiago City with Purchase Request No. 57183*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The *Santiago Water District (SANWAD)* now invites bids for the above Procurement Project. Completion of the Works is required *within 120 Calendar Days upon receipt of Notice To Proceed*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Interested bidders may obtain further information from *Santiago Water District (SANWAD) BAC Secretariat* and inspect the Bidding Documents at the address given below from *8am-5pm*.

A complete set of Bidding Documents may be acquired by interested bidders starting on *April 25, 2024 until May 17, 2024* from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Five Thousand Pesos (P 5,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person, by facsimile, or through electronic means*.

The *Santiago Water District (SANWAD)* will hold a Pre-Bid Conference<sup>1</sup> on *May 8, 2024 at 10:00 AM* at *SANWAD Conference Room* and/or through videoconferencing/webcasting *via Zoom or in person (at the option of the bidders)*, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, on or before *May 20, 2024 at 9:00 AM*. Late bids shall not be accepted.

All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

Bid opening shall be on *May 20, 2024 at 10:00 AM* at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
